Faculty Senate Budget Survey

On April 3, 2018 an email was sent to the presidents and administrative contacts (if known) to faculty senates at 24 universities that are peer or aspirational peers for the University of Tennessee, Knoxville UTK) and the University of Tennessee Agricultural Institute (UTIA). Below is a set of tables summarizing the information collected from 7 universities that responded by April 13, 2018. All of the universities that participated in the survey will be sent a copy of this study.

Executive Summary:

The faculty senates surveyed reflect a range of governance structures, and the budgetary allocations for their operations vary. The budgets reported as part of the survey may not be comprehensive, as some institutions have staffing support, or support for course releases that is not included in the reported budget. While not always comprehensive, the budgets range from \$39,591 to over \$250,000. In one case, the Faculty Senate is part of a larger office that addresses several aspects of faculty services and governance, so does not have a dedicated budget. At every university, the budget for the a faculty senate reports to the provost, vice-president of academic affairs, president or chancellor. Most faculty senates have an office, some have a dedicated conference room, with meetings of the full senate typically held in a large classroom or auditorium. Staffing levels range from a 1/3 administrative assistant to a full time administrative coordinator with a half/time administrative assistant. Typically, the faculty senate does not have a graduate research assistant, but one has undergraduate student assistants. Most institutions provide some form of release-time or summer stipend for the faculty senate president, and some extend this to other senate officers.

The total budget is flexible to allow adjustment of the pay structure covering the stipend provided to faculty elected and appointed faculty to positions supported by the Faculty Senate office. The budget can run from \$250,000 to \$300,000. The Faculty Senate has a departmental budget that is managed by the Director of University Faculty Governance
