On the advice of FA Committee Chair, the goal for the timeline is to deliver finalized proposed changes to the Faculty Affairs Committee before March 28, such that a first and second reading can be considered in the full Faculty Senate before the year is over. Key areas under consideration are 4.1, 4.1.1.1, 4.3, 4.5.1, 4.7, and 5.6. We are basing this effort both on the work and observations of the NTTI Committee and on the 2020-2021 Non-Tenure-Track Faculty Task Force's Report to the Office of the Provost. It is the goal to triangulate between the NTTI Committee, the Faculty Affairs Committee, and Office of the Provost to accomplish these adjustments to Faculty Handbook language and policy and improve the relationship of NTTF to the university, and vice versa. There are no current action items for the FSEC, but some should be anticipated in the coming months.
